Time to Start Thinking about Confirmation . . .



Our Confirmation program is an opportunity for our students to grow in their faith, and develop lasting relationships within the church community. Our program is a two- year program that runs from October thru April. We meet twice monthly. The first meeting of the month is on a Wednesday evening 6pm – 7:30pm. Parents will be asked to sign-up to provide the meals on Wednesdays. A confirmation mentor (in which the student will help choose) will help guide them through the lessons. The second meeting of the month will be an outreach event. Both meetings are required along with regular church attendance.

In addition to attending classes and church – the students will be asked to:

- serve as a greeter (along with family/friends) 3 times throughout the years
- serve as a liturgist, help with children's Sunday school, provide special music during worship, or serve in the bell choir 2 times a year
- memorize 1 scripture passage
- Take part in our Easter Service where students will have a special presentation

All of this information will be included in the confirmation packet for the class of 2023-2024.

Consistory Update – (July 2023)

Greetings from the Consistory! We hope you are enjoying your summer.

This month I would like to update you about the parking challenges we face at Swiss Church when the village closes 4th Avenue during festival celebrations.

It was brought to my attention by our local funeral director that during a recent festival and 4th Avenue closure, a member was ticketed while parked near our handicap accessible entrance on 4th Avenue during a funeral. I sought out both our New Glarus Chamber and New Glarus Police Department for more explanation. The police chief let me know that he rescinded the ticket, but we both agreed some explanation could help prevent future frustration.

It should be pointed out that the ultimate decision to close 4th Avenue for festivals is taken by the Village Board after a several months long process of review. At that point, it is the chamber and police department's responsibility to carry out the closed road order. However, after talking with both organizations, they are very willing to use their judgement and discretion to avoid unnecessary conflicts.

On the rare occasion when a church event like a funeral is scheduled at the same time 4th Avenue is closed for a festival please take a couple of precautions to avoid conflicts. Both the chamber and police department agreed that a vehicle with handicap accessible markings could be allowed to pass the closed road barrier; however, the vehicle should remain inside the barrier for just the time it takes to drop off their handicapped family member. Once the drop off has been achieved, the car should be returned to a parking area outside the closed road barrier for the duration of the event they are attending. There is a reason the chamber and police department insist on what others of us might consider an inconvenient restriction. During the months-long review of a request to close the road, one of the considerations is Fire and EMS access to areas inside the closed road area in case of emergency. The potential for parked cars inside the closed area is not a part of their consideration and therefore must be avoided, except for the very shortterm requirements for dropping off people at the church with limited mobility. There is also the unintended consequence of additional cars following the one with handicap markings, thinking that "if they did it, it must be allowed".

I hope this explanation has been helpful. As always, bring your questions about this or other concerns to the Swiss Church Consistory and we will investigate and address it.

Update on Cemetery Activity --

You may recall that the Swiss Church Consistory initiated discussions with the New Glarus Village Board last winter about transferring ownership and management of the Cemetery. While Swiss Church ownership and maintenance of the Cemetery made sense when it was the lone church in the community, it makes less sense now. Several new churches have been created in the decades since then and

the Cemetery serves as the final resting place for many people each year who are not members of Swiss Church. The money generated through plot sales each year does not come close to the annual cost of maintaining the Cemetery, so Swiss Church must then make up the difference. Attempts to get sustained financial support from other area congregations have gone nowhere.


Initial discussions with the Village Board met with significant resistance. There is a legal pathway for a church to "abandon" a cemetery but it takes years to achieve, and in the meantime the church cannot maintain the cemetery or the "abandonment" period starts over. As Memorial Day and summer approached, we experienced the inevitable unkept appearance of a cemetery in the abandonment process and the associated anger from our residents and family members who have loved ones interred at the Cemetery. Attorneys for the both the Village and Swiss Church negotiated an agreement by which Swiss Church would be allowed to mow and maintain the Cemetery, using Cemetery funds,

without restarting the abandonment time clock. We have and will continue to keep the Cemetery mowed until a mutually agreed upon transition plan is achieved.

Because initial discussions between the Village and Swiss Church were contentious, our Swiss Church attorney recommended all communications with the Village be between attorneys. Unfortunately, as of the time this article is being written, there have been no further discussion on the larger issue of transference of the Cemetery to the Village between the attorneys. The Consistory now plans to try and revive an amicable dialogue directly with members of the Village Board. We will keep you informed of any progress achieved.

Consistory Meeting-April 26, 2023

Approval of Agenda

Motion to accept agenda for meeting was approved

Approval of Last Month's Minutes

The minutes from the March 22, 2023 were presented. Motion to approve was made by Shelly Johnson, seconded by Tabatha Barnaby. All voted in favor to approve the minutes without changes.

Financial Report

- YTD information through March was presented by Shelly Johnson.
- Spire The month of March was strong for us financially. Our giving/income was \$24,410 (\$2,698 above budget) and our expenses were \$18,820 (\$2,390 under budget) which resulted in a Net Income for the month of \$5,590 (vs. a budgeted amount of \$503). This puts us in a solid position financially with a YTD Net Income of \$5,110 (which is \$7,200 ahead of the budgeted amount of -\$2,090).
- Shelly recommended consideration of a change to the budget for next year based on the increase in income.
- General fund balance is at \$65,665
- Discussion about two upcoming bills that Marlis is researching, both related to renewals for services that have had price increases. Marlis will follow up with Shelly when information is obtained.
- Offering 4/2/23- \$7,200
- Offering 4/9/23- \$3,950
- YTD income is \$58,154 with variance from the Spire report related to ETF/online donation.
- Motion to approve checks was made by Heidi Mondloch, with Tabatha Barnaby seconding this motion. All present voted in favor of approving checks as presented.

Committee Reports

Property-

- Shelly informed the consistory that she had Marlis mail a check to the attorney.
- The village has agreed to a meeting. Our attorney will have an upcoming listening session with the village administrator and the attorney will report back with information.
- No additional action is required at this time.
- Discussion was completed regarding the value of the cemetery, which is related to market values.
- Church spring cleaning date will be announced by the property committee.

Executive:

- Nancy Galhouse expressed to the consistory that she would like to step down from the president's position secondary to not having a co-president
- Discussion was completed about the role of the president position.
- Consistory members discussed reaching out to a former president or prior vice president to see if they may have interest in this position. The commitment would be until February 2024.

HR:

No report

Pastoral Report:

- Discussion was completed about senior high recognition day and how to provide gifts to graduating seniors, particularly to those unable to attend service on 5/21/23. The consistory recommended purchase of a non-dated gift. Pat will provide invitations to graduates and make announcements in church.
- Pat announced that the Joyful Hearts committee has opted to discontinue the Swiss Church food pantry. Vouchers to Roy's supermarket will still need to be paid.
- A motion to retain the remaining funds of \$873.47 for use for families who contact church with food insecurity or a food emergency was made by Nancy Galhouse and seconded by Heidi Mondloch, with all present voting to approve.
- Pat discussed reinitiating church services at the New Glarus Home. A date of Sunday, May 7, 2023 has been determined to
 resume services there. There was discussion about how to ensure safety of NGH residents. Masks and hand sanitizing will
 be available and provided. If NGH has Covid + residents, the services will be cancelled. A call will be placed prior to services
 to inquire about any types of infectious outbreaks that would necessitate cancellation of services. Nancy and Jessica will
 attend the first service.
- The consistory discussed payment for special music services and agreed that if a musician is leading music during the service, they will be compensated at a rate of \$75. Shelly will write a policy to this effect.
- Pat noted that she is continuing video/Bible study on Tuesday mornings May 2-30.
- Glarner Lodge service is scheduled for 5/4.
- There is a confirmation student being confirmed on 5/7 and a baptism scheduled for 5/21. Senior high recognition will also be on 5/21.
- There are required Clergy Conference meetings on 5/1, 5/11 and 5/25.
- Mission committee is scheduled for 5/10 and a staff meeting is scheduled for 5/18.
- The Water Walk is scheduled for 5/20.
- The Mission committee is planning to help with the Bike Rodeo in New Glarus on 5/20.

Swiss UCC Consistory Meeting May 24, 2023 Via Zoom

Meeting called to order by Shelly Johnson at 6:30 pm.

Approval of Agenda

The following item was added to the agenda - vote needed to add Kim Bright and Chris Kiesz to the Consistory; vote needed to elect Kim Bright president of the Consistory. Motion to approve was made by Nancy Galhouse, seconded by Jessica Swan. Motion carried.

Tabatha Barnaby made a motion to add Kim Bright and Chris Kiesz to the Consistory; seconded by Rachel Baker. Motion carried.

Tabatha Barnaby made a motion to elect Kim Bright president of the Consistory; seconded by Jessica Swan. Motion carried.

Nancy Galhouse agreed to serve as vice president. It is recommended that these changes to the Consistory be printed in the Spire.

Approval of Last April Minutes

An amendment was made to the Pastoral Report with the addition of the last seven bulleted items. Rachel Baker made a motion to approve the minutes as amended; seconded by Nancy Galhouse. Motion carried.

Diana Clark Request

Diana Clark requested permission to make a presentation regarding June Pride Month similar to her presentation last year. She will coordinate with Pat on a date. Kim Bright moved to grant permission; Nancy Galhouse seconded. Motion carried.

History of cemetery abandonment by Shelly Johnson

In October, 2022, a survey of church members indicated that the majority was in favor of abandoning the cemetery. After correspondence back and forth between the church and the Village in September, October, and November, on December 6 at the Village Board Meeting, they unanimously rejected our proposal to have the Village provide maintenance and operation of the cemetery for one year based on their attorney's advice. However, the Village is legally required to maintain and operate an abandoned cemetery after five years of abandonment. We then retained Attorney Nathan Russell to help us proceed.

Because we cannot mow the cemetery for fear of losing our abandonment date of January 1, 2023, the grass has taken over, some families are mowing their individual plots, and it looks terrible.

One possible solution was to be issued a "noxious weed" citation, have the Village mow it, and have the church pay for it.

Another option is to negotiate with the New Glarus Township which is apparently willing to contribute funds to the Village to maintain the cemetery.

The total cost of maintaining the cemetery to Swiss Church is approximately \$26,000, \$13,000 for mowing and snow removal on the property, and \$13,000 for administrative costs of selling plots and maintaining records which is currently being done by volunteers since Kristina Schneider resigned. Bonnie Klassy believes the existing system of selling plots and maintaining records should be scrapped. The administrative tasks are laborious, sometimes working from hand-drawn schematics. These tasks average 4-10 hours per week.

Attorney Russell and Bonnie Klassy joined the meeting via Zoom.

Mr. Russell met with the Village Administrator, Village President, and their attorney on Monday, May 22. Overall, he was optimistic that they will continue to work with us on the transfer in some regard.

Mr. Russell stated that the church's point was made. The church has abandoned the cemetery and is transferring the maintenance and administration of the cemetery to the Village.

Because of the number of complaints the Village has received on the condition of the cemetery, with Memorial Day approaching, they agreed to have the church continue to mow it, with written assurance that it will not affect our abandonment date. They would like us to continue maintenance for one year. They also agreed that we can continue to sell plots and operate administratively as we did before.

They asked for an inventory of plots occupied, plots sold but unoccupied, and remaining plots.

They also asked for the exact amount of funds they would receive from the church should the transfer take place. Current balances as of 5/25/23 are Bank of New Glarus - Cemetery Checking Account from which the mowing is paid is \$11,237.27; Bank of New Glarus - Cemetery Savings Account is \$10,292.45; and United Church Funds - Cemetery Perpetual Care is \$106,323.79 Market Value/\$57,996.64 Book Value. Mr. Russell will get this information to their attorney.

Once this information is given to them, they will have further conversations and hopefully create a draft proposal at some point, but there is no timetable for how long this may take.

Kim questioned our liability regarding perpetual care for those who purchased plots in the past if the cemetery is not maintained. The quandary is what is our obligation to those who have bought plots. There is no case law or statutes regarding this.

Mr. Russell asked for our sense of whether the Village's reluctance to take over the cemetery is funds needed for cemetery upkeep or manpower for administrative functions. His sense is that it's manpower, especially if the Town is willing to help with funding. Shelly feels that they have plenty of administrative manpower.

Shelly asked about communicating this information to the general public. Mr. Russelll advised that we say nothing about the negotiations occurring at this point because of the side agreement to continue mowing. He will draft a short statement we can say when questioned about the progress being made and send it to Shelly. At some point a joint statement can be published.

Attorney Russell and Bonnie Klassy left the meeting at this point.

Financial Report

Shelly Johnson reported that we are good financial shape.

Spire - Our giving/income was \$25,832 (\$3,636 above budget) and our expenses were \$17,617 (\$1,657 under budget) which resulted in a Net Income for the month of April of \$8,216 (vs. a budgeted amount of \$2,023). This puts us in a solid position financially with a YTD Net Income of \$13,337 (which is \$12,505 ahead of the budgeted amount of \$832.

The General Fund has a balance of \$75,753; Property \$81,878; Cash Reserve \$55,089; and Cash Reserve CD \$50,000.

Checks were reviewed. Shelly Johnson moved to approve the checks as listed; Kim Bright seconded. Motion carried.
