My daughter-in-law sent me this picture. My five-year-old grandson is learning a good deal about Jesus. She told me they keep his small nativity set up year-round. They had

been talking about Jesus and reading books about Him. He showed his parents how he set up his Teenage Mutant Ninja Turtles – a popular children's toy based on the superhero film. His turtles are protecting the infant Jesus. He knows that Jesus grew to be



our Savior. He doesn't understand all the details about what that means just yet. I don't believe any of us can fully comprehend the gift we received from Jesus at Easter.

And yet, even in the innocent heart of a child, there is a glimpse of something profound. My grandson understands, in his own five-year-old way, that Jesus is someone worth protecting- worth honoring. To him, Jesus is important enough to deserve the watchful guard of his favorite heroes. What a wonderful year it has been with our confirmation class! Our second-year students will be confirmed during the 9:00 AM service on Sunday, May 4th.


We'll hold a brief rehearsal on Saturday, May 3rd, from 9:00 to 9:45 AM.

Sunday, May 18th – 9 AM worship we would like our graduating seniors to come forward during worship so we might share your future plans and pray for you. Congratulations on your



Swiss UCC Consistory Meeting Minutes March 26, 2025

Kim Bright called the meeting to order at 6:30 p.m. Pat Pluss led us in prayer.

Agenda

Jon Ziltner moved to approve the edited agenda; Gary Krahenbuhl seconded. Motion carried unanimously.

Approval of Consent Agenda

The Consent Agenda to approve the February minutes, Treasurer's report, and checks written was made by Kim Bright; seconded by Chris Kiesz. Motion carried unanimously.

Treasurer's Report for Financial Statements ending February 28, 2025

Income for February was \$21,489 which included \$3,517 of interest from the CD redeemed. Expenses for February were \$19,308 leaving a net profit of \$2,182. Income year-to-date is \$46,627 and expenses were \$38,307 for a net profit of \$8,320 compared to 2024 profit of \$5,769 for the same time period.

The \$17,500 gift from Planned Giving to Property Fund for 2025 increased the Property Fund checking account balance to \$147,025.

Total expenses for January and February are \$38,307 compared to budgeted expenses of \$42,329, so everything is looking good so far!

Jon Ziltner moved to transfer the excess cash from both the General and Property Funds to Vanguard money market accounts. Marlis Silver will be the primary person authorized to act on the account. Kim Bright, President of the Consistory, and Jon Ziltner, Treasurer of the Consistory, will also be authorized to act on the account. Steve Rossing seconded the motion. Motion carried unanimously.

Old Business

- Phase 1 of the repairs to the pipes and sprinkler heads in Fellowship Hall has been completed.
- The lockbox in the bank foyer will be moved to the north side wall of the church. (Thank you, Steve Rossing)

- Kim Bright will contact Matt Streiff again regarding livestreaming the Easter service at the New Glarus
 Home. With good results, this practice could continue in the future, and a live service could possibly be
 scheduled during the week.
- Kim Bright noted that \$33,950 from the sale of the land to the Village of New Glarus has been transferred to the Property Fund, along with a gift from the realtor in the amount of the commission from the sale.
- Jon Ziltner reported the initial comments made by the architect after consistory members' meeting with him.
- The New Glarus Library Board will collect books and store them at Zwingli until the time of their annual sale.
- Kim Bright moved to form a committee to research the details involved in the remaining two options for offices, Sunday School, and storage: refurbishment of Zwingli or construction of a new building; Rachel Baker seconded. Motion carried unanimously.

Rachel Baker moved to adjourn; Jon Ziltner, seconded. Motion carried unanimously. Meeting adjourned at 7:28 p.m.

Consistory Update - May 2025

After a busy couple of months and with conclusions to reoccurring agenda items for cemetery transfer, land sale, the township building move question and the office move; this past month has been much quieter with a shorter consistory agenda. Adding, that the budget is in a good position, I can say I have not experienced the consistory agenda with so few pressing issues in my two consistory terms. Our last couple consistory meetings have been completed in our targeted time of less than an hour.

The sprinkler leak issue in the basement has been resolved for now and hopefully for the long term, so we can take this reoccurring issue off the monthly consistory agenda. After a couple of years just fixing the leaks, an effort was made to get to the source of the issue, which was caused by bacteria in the sprinkler water, causing the pipes to erode. Steps were taken to alleviate the issue causing the bacteria and in doing so, all the pipes and sprinklers in the basement were replaced. A huge thank you to all involved in resolving this issue.

Enhancing our technology for both in person and online services is an issue that makes the Consistory agenda, on occasion. Our online services have been very successful, and with technology constantly changing we can expect this

to continue to be added to the agenda, occasionally.

The future issue that will take center stage, will be the Zwingli house restoration/new build and subsequent building decisions; therefore, a committee is being formed to take the initial steps of gathering information and costs for both options.

I recently went online to do some study of historic building restoration, a subject which I had never researched until now. There are many resources available online for historic building rehab information, and I chose the Wisconsin Historical Society, as my main source. A couple of things I found interesting - The first is that those that have a connection to a particular historic building tend not to be the people that have interest in historic rehab, for that building. People that have no connection to the building tend to have more interest, if a rehab is proposed. Second, the cost of a rehab with historic preservations compared to a rehab without the historic preservations or simply refurbished to a usable state, can cost three to four times as much.
